## **HIGH SCHOOL VOLKSRUST – HOSTEL**

### MUST BE COMPLETED BY EVERY PARENT/GUARDIAN FOR ADMISSION OR RE-ADMISSION TAKE NOTICE OF THE FOLLOWING:

An annual first payment of **R3 000,00** is charged per student. This fee must be paid before the learner is admitted into the hostel at the start of each academic year.

Learners will only be admitted into the hostel once proof of payment of the administration fee has been produced.

Returning students will not be admitted to the hostel if the fees for the previous year have not been paid in full.

A payment Agreement Form must be signed at registration, denoting payment terms for hostel fees for the new academic year. Hostel fee structures are available from the Hostel Manager or the Financial Office.

Hostel fees are payable in advance, and if paid monthly, such payments must be made by the 7th of each month.

A Letter of Agreement for damages must be signed by the responsible parent/guardian

Learners who wish to make use of the internet must complete an application form from Mr Claassen . Internet access is restricted to a maximum of 2 hours per day per student. **Internet is only available for schoolwork.** 

The hostels close on Fridays at 14:00 and re-open on Mondays at 07:00. If a learner needs to stay in on Friday for sport, the hostel mother /-father must be informed. A learner is responsible for his/her own meals.

If a learner arrive on Sunday the following rules apply:

- He/she must sign in between 16:00 and 17:00
- No learner can leave the school grounds without the permission of the hostel mother /-father

2. First payment of  $\pm R3000$  is non - refundable

### Cost per learner currently : R31 500 + 10% escalation for 2023

### **Payment options:**

- 1. 10% discount if settled on or before registration day of the current year, should the parent/s fail to make payment as per this undertaking the full amount payable for the years school fees will be due and payable immediatly the day after registration day and the parent/s waive the discount of 10% due to his/her/their/ non-payment.
- 2.  $\pm$  R3 000.00 first payment payable in addition to any school fees must be paid on or before the registration day of the current year.
- 3. 8% discount if settled on or before 28 February, should the parent/s fail to make payment as per this undertaking the full amount payable for the years school fees will be due and payable by 01 March and the parent/s waive the discount of 8% due to his/her/their/ non-payment.
- 4. 5% discount on ten equal monthly debit order payments, first payments payable on or before 29 January and each insalment thereafter on or before the 7th of each consecutive month. Should the parent/s fail to make any one or part of these monthly instalments the full outstanding amount for the hostel fees will be due payable immediately.
- 5. Ten equal monthly cash payments, first payments payable on or before 31 January and each insalment thereafter on or before the 7th of each consecutive month. Should the parent/s fail to make any one or part of these monthly instalments the full outstanding amount for the hostel fees will be due payable immediately. By failing to pay any of these instalments, accomodation in the hostel wil be suspended
- 6. Four equal term debit orders/cash payments, first payments payable on or before 31 January and each insalment thereafter on or before the 7th of each consecutive term. Should the parent/s fail to make any one or part of these term instalments the full outstanding amount for the hostel fees will be due payable immediately. By failing to pay any of these instalments, accomodation in the hostel will be suspended.
